#### MSU Research Information Items:

- FY 2025 Research Data
  - VP Harmon reported on Research Expenditures FY 25.
  - NSF HERD total \$288.7M (12% growth)
  - OSP only: \$229.3M: effective IDC rate: 17.3%
  - IDCs Collected: \$33.8M
  - Research Funding Sources: Federal 92%, Private 6%, State 2%
  - Supporting Student in Research:
    - ✓ Graduate Student: 654
    - ✓ Undergraduates: 803

- ✓ Total Student Support: \$14.5M
  - USP Awards: 172: Total USP Funding: \$269,559
  - Proposals & PIS: The Number of proposals is lower. The number of PIs is up by 10% from last year, but lower than in previous years. The requested amount is lower. New awards opened less than previous year.
  - Forecasting models have been developed to help predict our research revenue.
  - IDCs invested in FY 2025: MSU's research funding showed strong growth, heavily reliant on federal sources, particularly the Department of Defense.
    - ✓ Internal Awards 3.9% (\$1.35M)
    - ✓ Faculty Support 14.5% (\$5M)
    - ✓ Colleges/Units/Centers & Institutes 27% (\$9.3M)
    - ✓ Core Facilities 8.1% (\$2.8M)
    - ✓ Research Security & Compliance 3.5% (\$1.2M)
    - ✓ Research & Infrastructure & Facilities 34.8% (\$12M)
    - ✓ Research Administration & Operations 8.3% (\$2.9)
    - Total \$34.7M
  - Connected with the liaison from the Alumni Foundation and established an endowment for research.
  - Graduate enrollment declined due to international students' visa issues, impacting future research productivity.
  - Continued students showed persistence rates, indicating stability within the existing student population
  - Less funding opportunities for agencies. But that doesn't mean we shouldn't try to complete.
- Federal Funding and the MSU Research Landscape
  - Federal appropriations discussions are ongoing, with uncertainty around budget outcomes
- Research Subjects Database
  - Updating a human subject recruitment database for research participation.
  - Postcards were sent to Gallatin County to fill out a brief survey to recruit people to be part of the research database.
  - Building an internal database specific to the Montana community, which is open to students, faculty, and staff. Goals to connect participants with MSU investigators.
  - Generating awareness, and over 300 participants have signed up for the database.
  - Planning a meeting with MSU Billings to explore how to utilize their resources for participants, and reach out to the extension offices to get to the Rural area
  - Develop a communication strategy to engage alumni.
  - Required an IRB approval to use the MSU human subject recruitment database.

#### Discussion Topic:

- Communicating the impact of MSU research

- How do we measure the impact
  - Met with various groups to think of research impacts. MSU and other Institutions measured by research expenditures, economic impact, number of patents and start-ups, community engagement, and number of academic papers published
  - Need Impact Measures Brainstorm; Key Questions: Who is the audience? What story are we telling? Accuracy? Difficulty in measuring?
  - How can we connect new jobs to startups and other businesses?
  - Replacement of students into high-paying jobs.
  - Forecast workforce demands and how to fill that demand
  - Effective communication of research impact is crucial for public awareness and appreciation.
  - Highlighting successful alumni can foster pride in MSU's contributions to the State.

  - USDA NIFA Foundational Applied Science Program Request for Applications posted August 1.

  - Section 216 of the Senate version of the [National Defense Authorization Act for FY26](#) includes a prohibition against contracts or affiliations with certain foreign entities, specifically foreign academic institutions identified within the “[1286 List](#)”. If passed in current form, such contracts or affiliations would potentially risk current and/or future Dept. Of Defense funding to MSU.
